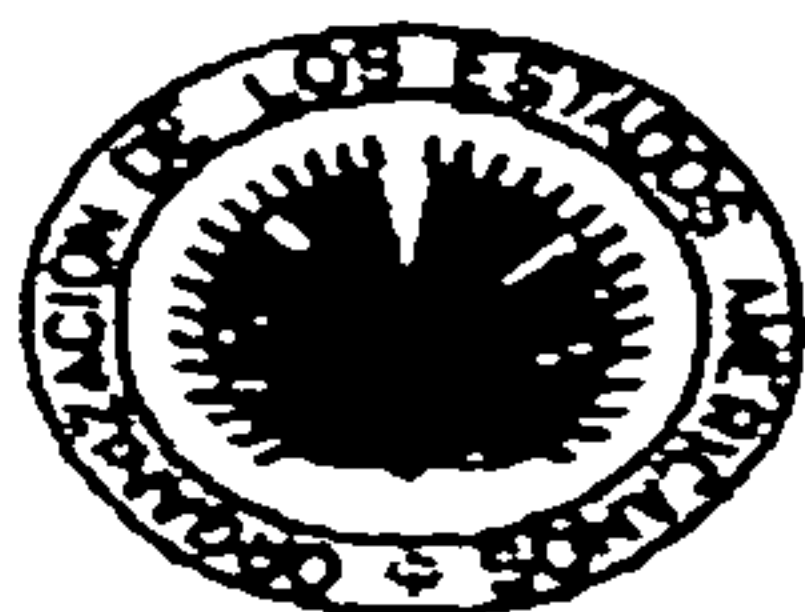

Your Excellency:

I am writing in regards to your fax of April 15, 1997, in which you present the Inter-American Court of Human Rights a copy of a note from the Minister for Foreign Affairs a.i. for Suriname, His Excellency P.R. Sjak Shie, regarding your Illustrious Government's compliance with the Inter-American Court's Judgments in the Gangaram Panday and Aleoboetoe *et al.* Cases.

Additionally, please find included with this communication a copy of the note from the Inter-American Commission, dated today, in which it provides the current address and telephone number of the family of the victim in the Gangaram Panday Case in order to facilitate payment of the ordered reparations.

The Inter-American Court has already closed the Aloeboetoe *et al.* Case and with this upated information it will consider closing the Gangaram Panday Case during its next Regular Session. YOUR communication was transmitted to the Inter-American Commission for its observations.

Tengo el agrado de dirigirme a usted con el objeto de reiterarle la solicitud realizada por esta Secretaría el 16 de abril de 1997 (REF: CDH-150.571), referente al envío de las observaciones de la Comisión Interamericana de Derechos Humanos al escrito del Ilustrado Estado de Suriname (Wash/128/OAS/RA/hn), cuya copia le fuese transmitida en esa oportunidad.

La Corte requiere las observaciones de la Comisión al cumplimiento, por parte de dicho Estado, con lo dispuesto por la Corte Interamericana de Derechos Humanos en la sentencia de 21 de enero de 1994 en el caso Gangaram Panday y, específicamente, sobre si la señora Drobotie Panday ha sido notificada del depósito judicial que ha sido hecho a su nombre y ha reclamado dichos fondos.

Por estas razones, me permito solicitarle las observaciones de la Comisión sobre el escrito citado a la brevedad posible.
