

**ORDER OF THE PRESIDENT OF THE
INTER-AMERICAN COURT OF HUMAN RIGHTS
SEPTEMBER 11, 2020**

**REQUEST FOR ADVISORY OPINION OC-28
SUBMITTED BY THE REPUBLIC OF COLOMBIA**

HAVING SEEN:

1. The request for an advisory opinion submitted to the Inter-American Court of Human Rights (hereinafter "the Inter-American Court" or "the Court") by the Republic of Colombia on October 21, 2019 on the "Figure of indefinite presidential re-election in the context of the Inter-American System of Human Rights". The State appointed Mr. Camilo Gómez Alzate, Director of the National Agency of Legal Defense of the State, as its agent for this request.
2. The notes of the Secretariat of the Court (hereinafter "the Secretariat") of February 18, 2020, in which, pursuant to Articles 73(1) and 73(2) of the Court's Rules of Procedure (hereinafter "the Rules of Procedure"), it communicated all the Member States of the Organization of American States (hereinafter "the OAS"), the OAS Secretary General, the President of the OAS Permanente Council, and the Inter-American Commission on Human Rights, that the President of the Court, in consultation with the Court, had set May 18, 2020, as the deadline for the submission of written observation on this request.
3. The notes of the Secretariat of February 18, 2020, and the publication on the Court's website, in which, pursuant to Article 73(2) and 73(3) of the Rules of Procedure, the President invited all the interested parties to present their written opinions on the points submitted for consultation and set May 18, 2020, as the deadline for this purpose.
4. The Court's decisions Nos. 1/20 and 2/20 of March 17, 2020, and April 16, 2020, and their publication on the Court's website, by which it was determined to suspend all deadlines from March 17 to May 20, 2020, because numerous countries in the region were affected by the COVID-19 pandemic, classified by the World Health Organization as a global health emergency.
5. The request of an extension of the deadline submitted by the Inter-American Commission on Human Rights on July 24, 2020, and the note in which the President of the Court granted the extension.

8. The notes of the Secretariat of August 14 and 27, 2020, in which it requested the different delegations to confirm and present their accreditations for the public hearing, and the confirmation of fifty-three delegations on this regard.

CONSIDERING THAT:

1. The Court's Secretariat received numerous briefs with observations and relevant documents on the request for an advisory opinion within the established time frame (supra having seen paragraphs 6, 7 and 8).

2. The written observations of Corporación Centro de Interés Público y Justicia (CIPJUS) and of Instituto de Gobernabilidad del Perú (INGOPE) were presented on July 25, 2020. The President notes that these observations were submitted one day after the time frame had expired. However, given the nature of this matter, since it is not a contentious case but rather an advisory procedure, the right of defense is not affected. Therefore, with the purpose of allowing the Court to take into account all the contributions received, the incorporation of the said briefs into this procedure is exceptionally authorized. On the other hand, the written observations of Esteban Yanguas Ramón and José Fernando Flórez Ruiz were presented on August 24, 2020, one month after the deadline, which the President consider excessive and it is therefore not admitted.

3. The Court finds it desirable to hold the oral procedure established in Article 73(4) of the Rules of Procedure, and that the Inter-American Commission, the Member States, and those who submitted their written observations and confirmed their participation on the hearing present their oral arguments. Due to the exceptional circumstances caused by the COVID-19 pandemic, this oral procedure will be held virtually.

THEREFORE:

THE PRESIDENT,

pursuant to the provisions of Articles 24(1) of the Statute of the Court and 73(4) of the Court's Rules of Procedure, and in exercise of her authority under Article 31(2) of the latter,

DECIDES:

1.
