ORDER OF THE PRESIDENT OF THE INTER-AMERICAN COURT OF HUMAN RIGHTS OF OCTOBER 13, 2023

REQUEST FOR ADVISORY OPINION OC-30 SUBMITTED BY THE UNITED MEXICAN STATES

HAVING SEEN:

- 1. The request for an advisory opinion submitted to the Inter-American Court of Human Rights (hereinafter "the Inter-American Court", "the Court" or "the Tribunal") by the United Mexican States (hereinafter "Mexico") on November 11, 2022 in relation to "the activities of private companies engaged in the firearms industry and their effects on human rights" The State appointed Alejandro Celorio Alcántara, Legal Adviser; Martha Delgado Peralta, Undersecretary for Multilateral Affairs and Human Rights; Roselia Margarita Barajas y Olea, Ambassador of Mexico to Costa Rica; Cristopher Ballinas Valdés, Director General for Human Rights and Democracy; Salvador Tinajero Esquivel, Deputy Legal Adviser; Víctor Manuel Sánchez Colín, Head of Chancellery of the Mexican Embassy in Costa Rica; Aída Margarita Flores Díaz, Counselor of the Mexican Embassy in Costa Rica; Alfredo Uriel Pérez Manriquez, Director for International Courts and Organizations and Rubén Darío Álvarez Ángeles, Deputy Director for International Courts and Organizations, all from the Ministry of Foreign Affairs, as its agents for this request.
- 2. The brief of November 25, 2022, through which Mexico presented the translations into the other three official languages of the Organization of American States (hereinafter "the OAS") of its request for an Advisory Opinion.
- 3. The notes of the Secretariat of the Court (hereinafter "the Secretariat") of March 7, 2023, in which, pursuant to Articles 73(1) and 73(2) of the Court's Rules of Procedure (hereinafter "the Rules of Procedure"), it advised all the OAS, the OAS Secretary General, the President of the OAS Permanent Council, and the Inter-American Commission on Human Rights, that the President of the Court (hereinafter "the President"), in consultation with the Court, had established July 10, 2023, as the deadline for the presentation of written observations on this request. Also, the notes of the Secretariat of July 4, 2023, in which this deadline was extended until August 21, 2023, which was notified to all those mentioned above.

- 4. The notes of the Secretariat of March 13, 2022, and the publication on the Court's website, in which, pursuant to Article 73(2) and 73(3) of the Court's Rules of Procedure, the President invited all those who were interested to submit their written opinion on the issues raised in the request and advised that the Court had established July 10, 2023, as the deadline for receiving such opinions, and also the publication on the Court's website, advising that this deadline had been extended until August 21, 2023.
- 5. The brief of written observations submitted by Mexico to their own request.

The written observations of the Instituto Internacional de Responsabilidad Social y Derechos Humanos (IIRESODH) and the Centro de Derechos Humanos Miguel Agustín Pro-Juárez were submitted on August 22, 2023. Likewise, the written observations of the Centro de Justicia de las Américas (CEJA) were submitted on August 29, 2023.

CONSIDERING THAT:

1. The Secretariat of the Court received numerous briefs with relevant observations and documents regarding the request for an advisory opinion before the established deadline (*supra*, having seen paragraphs 5 to 11). On the other hand, with the purpose of considering all the contributions received, the Presidency exceptionally authorizes the incorporation of the briefs that were submitted days after the established deadline (*supra*, having seen paragraph 12).

- 2. Given the advisory nature of this matter, those OAS Member States that have not submitted written observations in this case may present their oral arguments during the public hearing if they deem it relevant.
- 3. The Court finds it desirable to hold the oral procedure established in Article 73(4) of the Rules of Procedure, and that the Inter-American Commission, the Member States, and those who submitted their written observations present their oral arguments.

THEREFORE:

THE PRESIDENT,

Pursuant to the provisions of Articles 24(1) of the Statute of the Court and 73(4) of the Court's Rules of Procedure, and in exercise of his authority under Article 31(2) of the latter,

DECIDES:

- 1. To convene a public hearing to be held on November 28 and 29, 2023, starting at 8:00 a.m., at the Headquarters of the Court in San José, Costa Rica, during the Court's 163st regular period of session, in order to receive oral arguments on the request for advisory opinion OC-30 presented by the United Mexican States.
- 2. To request the Member States, the Inter-American Commission on Human Rights, and those who submitted written observations to inform whether they wish to take part in the hearing called by the President by October 27, 2023, at the latest, and to inform the Secretariat of the name and information of the persons who will be present during the hearing.
- 3. To require the Secretariat of the Inter-American Court to notify this order to the requesting State, to the other Member States of the Organization of American States, to all the organs mentioned in Article 73(1) of the Court's Rules of Procedure and to all those who submitted written observations on the request for advisory opinion OC-30.
