## THE INTER-AMERICAN COURT OF HUMAN RIGHTS TO HOLD ITS 177<sup>th</sup> REGULAR SESSION

*San José, Costa Rica, June 6, 2025.* The Inter-American Court of Human Rights will hold its 177<sup>th</sup> regular session from June 9 to 13, 2025, virtually. During this session, the Court will conduct deliberations and evidentiary procedures in two cases.

### I. Evidentiary procedures in cases at the merits stage

#### A. *Case of López de Belva and Podestá v. Argentina*<sup>1</sup>

In the case of *López de Belva and Podestá v. Argentina*, the Court will conduct a private oral evidentiary procedure to hear the statement of one alleged victim. This procedure will take place virtually on June 12, 2025.

#### B. *Case of Fiallos Navarro v. Nicaragua.*

In the case of *Fiallos Navarro v. Nicaragua*, the Court will conduct a private oral evidentiary procedure to hear the statement of one alleged victim and one witness. This procedure will take place virtually on June 13, 2025.

### II. Pending matters, monitoring compliance with decisions, and administrative issues

In addition, the Court will continue to examine various pending matters and will monitor compliance with several judgments and the implementation of provisional measures in matters that have been submitted to its consideration. It will also attend to several administrative issues.
