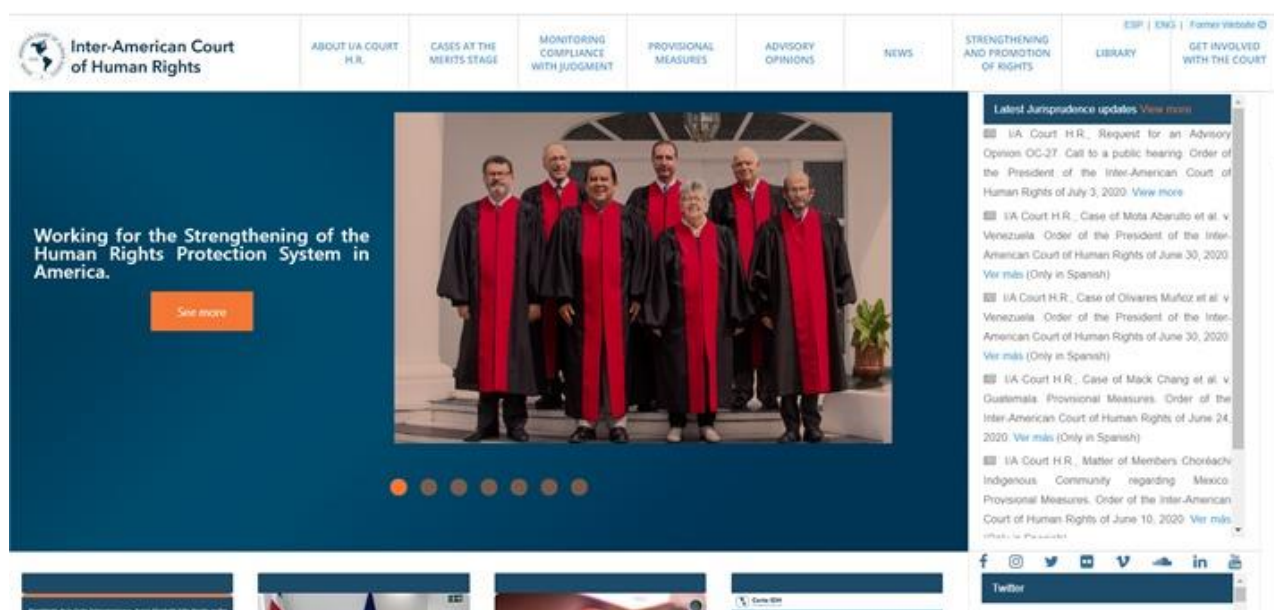

INTER-AMERICAN COURT OF HUMAN RIGHTS RELEASED ITS NEW WEBSITE



San José, Costa Rica, July 7, 2020.- Today, the Inter-American Court of Human Rights released its new website, in order to facilitate access to the information about the Court's work and activities.

"By means of these channels of communication, the Court is trying to be closer to the people, providing relevant information in an accessible manner so that they can understand how the Inter-American System of Human Rights works", said the President of the Inter-American Court, Judge Elizabeth Odio.

The new website contains the Court's complete case-law: Judgments, Advisory Opinions, Orders Monitoring Compliance with Judgment, and Orders on Provisional Measures, among other sections.

The website includes audiovisual contents that allow individuals to understand the different functions of the Inter-American Court in a plain language. These contents include video subtitles and audio-explanatory guides that are useful for persons with some kind of disability.

The website is available both in English and Spanish. It is expected that the Portuguese version will be available in the short term.

The News section includes all the current information about the Court, as well as Podcasts, Videos, Infographics, etc.

An interactive case-law map can be found at the home page, where the user can access the work of the Court in each one of the countries that signed the American Convention on Human Rights. Also, the Case-Law Booklets of the Inter-American Court can be found organized by topic.

In the Library section you can find all the information regarding our bibliography services, online catalogue, thesaurus, among others.

Moreover, in the section "Get Involved with the Court" the information has been organized taking into account the different audiences of the Inter-American Court.

Audiovisual feature stories on monitoring compliance with Judgment will be published periodically in the new webpage. Advances on the reparations of human rights violations in different countries of the continent will be presented through the voice of the victims.

The new website is the result of the joint work of all the Areas of the Secretary of the Inter-American Court, and has been possible thanks to the support of the European Commission.

This press release was produced by the Secretariat of the Inter-American Court of Human Rights, which is the only responsible for its content.
