INTER-AMERICAN COURT OF HUMAN RIGHTS WILL PERFORM AN ON-SITE VISIT TO THE YANOMAMI TERRITORY IN BRAZIL AND WILL HOLD HEARINGS FOR MONITORING COMPLIANCE WITH JUDGMENT IN BRASILIA

San José, Costa Rica, October 20th, 2023. A delegation of the Inter-American Court of Human Rights will perform an *on-site visit* to the Yanomami Territory in Brazil, in the context of the provisional measures of the *Matter of Members of the Yanomami, Ye'kwana and Munduruku* Indigenous Peoples. The delegation will be composed of Judge Eduardo Ferrer Mac-Gregor Poisot, Vice President of the Court, and Judge Nancy Hernández López, accompanied by the Court's Registrar, Pablo Saavedra Alessandri and the attorney from the Registrar's Office, Rita Lamy. The visit of the indigenous territories will take place from October 23th to October 25th, 2023.

Hearings on Monitoring Compliance with Judgment will be held during October 26th and 27th, for the following cases: *Herzog et al. v. Brazil*, *Case of Workers of the Fireworks Factory of Santo Antonio de Jesús v. Brazil*, and *Case of Favela Nova Brasilia v. Brazil*. The Hearings on Monitoring Compliance with Judgment will be held by a delegation composed of the President of the Court, Judge Ricardo C. Pérez Manrique, the Vice President, Judge Eduardo Ferrer Mac-Gregor Poisot and Judge Nancy Hernández López, accompanied by the Registrar, Pablo Saavedra Alessandri, the Director of the Unit for Monitoring Compliance with Judgment, Gabriela Pacheco Arias and the attorney of the Registrar's Office, Agostina Cichero. These are private hearings.

During the visit to Brazil, the delegation will meet with several State authorities.

Periodic reporting on the activities of this visit will be performed through the official channels of the I/A Court H.R.
