PROCEDURAL DEADLINES EXTENDED DUE TO YEAR-END RECESS OF THE INTER-AMERICAN COURT OF HUMAN RIGHTS

San José, Costa Rica, November 29, 2023.- The Inter-American Court of Human Rights communicates that, in accordance with Agreement 1/2014 on the calculation of deadlines, it will be in recess from Thursday December 31, 2023, to Friday, January 5, 2024.

For purposes of the processing of matters before the Court, the deadlines that fall during that period will be extended to Monday, January 8, 2024. This does not apply to Provisional Measures.
